Part A: Pupil premium strategy plan

Statement of intent

Our pupil premium strategy plan focuses on two key aspects: closing academic gaps in knowledge and supporting social and emotional development. Our ultimate objectives are for the gaps between disadvantaged and non-disadvantaged pupils at the schools to be negligible and for our disadvantaged pupils to leave our schools ready for their journey into their next school and ultimately into adulthood.

Our pupil premium strategy plan works towards this by providing excellent teaching and learning support through well-timed interventions and by providing opportunities and experiences that will enable our children to thrive in their chosen career later in life.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

1	<p>Writing – children’s writing has not reached pre-pandemic standards due to the impact of not having modelled writing in quality first teaching during the Lockdown periods</p> <p>2023 Update: School data shows that writing is still an area to develop and that it is not yet on a par with other Core Subjects.</p>
2	<p>Attendance – this continues to be affected by Covid-19 and is an area of development within the school.</p> <p>The November 2017 Ofsted highlighted Attendance as an area to develop and this has been a whole school focus since.</p> <p>2023 Update: Attendance remains a school focus, as attendance is below pre-pandemic levels, therefore needs improving.</p>
3	<p>Data shows a gap between Pupil Premium children and Non Pupil Premium children and the school will be prioritising closing this gap.</p> <p>2023 Update: School data continues to show a gap between PP and Non PP children in most year groups, therefore this remains a focus.</p>
4	<p>The impact of the Coronavirus pandemic, added to the demographic of the school has led to many children not having life experiences that will develop cultural capital and open children’s minds to the potential of activities and careers that could be pursued later in life.</p> <p>2023 Update: The Cost of Living Crisis, following the pandemic has meant that this continues to be a priority, as children are not getting opportunities to have life experiences.</p>

5	<p>Parents and carers are unable to contribute to the cost of uniform, educational visits and Breakfast club due to the rises in cost of living and energy prices.</p> <p>2023 Update: The Cost of Living Crisis has meant that this is a definite issue which continues to need prioritising.</p>

To improve life experiences and opportunities to develop cultural capital and children's potential for the future	<p>In the 2023 to 2024 year:</p> <p>Funding will be given to each year group in order for children to have real life experiences, such as educational visits or visitors.</p> <p>3 Year Plan:</p> <p>A plan of yearly experiences offered to the children will be developed to ensure a wide</p>

	range of experiences that help children understand their curriculum learning and develop their ideas for future careers.

Forest School provision for all pupils to develop wider life experiences and to develop vocabulary	Evidence shows that Forest Schools can contribute to the development of collaborative learning skills, by encouraging children to work with others on challenging outdoor activities; equip children with practical skills and an appreciation for being outdoors, which they can then transfer to family activities outside of school and to move towards an inclusive way of developing children beyond academic skills and giving a more rounded educational experience (https://www.lboro.ac.uk/media-centre/press-releases/2017/october/study-reveals-forest-school-benefits/)	4

<p>Contribution to Educational Visits costs for PP children</p>	<p>This fund will enable all Educational Visits for PP children to be partially funded, enabling the teachers to plan educational visits that will give life experiences to help children embed their learning across the curriculum. It will allow all year groups to plan additional visits that will support their curriculum.</p> <p>Written evidence for this is not detailed, however previous experience has shown the value of these trips and visits (https://educationendowmentfoundation.org.uk/education-evidence/teaching-learning-toolkit/outdoor-adventure-learning).</p>	<p>4 and 5</p>
<p>Purchase of Resources to support independent learning and life experiences</p>	<p>This fund will enable children in EYFS to develop independent skills, such as hand washing, as well as KS1 children with cooking activities. It will also enable EY children to have resources that enable them to develop in the 7 areas of learning.</p>	<p>3 and 4</p>

Intended outcome	Success criteria
To raise the percentage of children reaching age related expectations in Writing	<p>In the 2022 to 2023 year:</p> <p>Target: Children's outcome in writing are closer to pre-pandemic levels</p> <p>Review: In 2022, 24% of Year 3 reached the expected standard. This improved to 35% by the end of Year 4. Year 4 improved from 39% to 58% and Year 5 improved from 65% to 70%</p>
To decrease the difference between children entitled to Pupil Premium (PP) and those not entitled to PP	<p>In the 2022 to 2023 year:</p> <p>Target: The gap between PP and Non PP children is narrowed.</p> <p>Review: From 2022 to 2023, the gap decreased or Year 3 in Maths, however there was increase in Reading and Writing. In Year 4, the gap decreased in all three subjects. In Year 5, the gap increased in all three subjects and in Year 6, the gap decreased for Reading and Writing, but increased for Maths.</p>
To lower the percentage of children whose attendance is below 97%	<p>In the 2022 to 2023 year:</p> <p>Target: The Attendance Officer will send letters to parents and carers with absence below 95% and will hold meetings with parents and carers of children with particularly high absence.</p> <p>Review: Letters have been sent to all parents and carers with absence below expectations.</p> <p>Attendance in 2021 to 2022 was 94% and this was the same in 2022 to 2023. Persistent absence increased very slightly from 17.4% to 18.6%.</p>
To improve life experiences and opportunities to develop cultural capital and children's potential for the future	<p>In the 2022 to 2023 year:</p> <p>Target: Funding will be given to each year group in order for children to have real life experiences, such as educational visits or visitors.</p> <p>Review: Additional funds were given to year groups to support visits such as the Year 5 Harry Potter trip and the Year 6 Science Museum trip.</p>
To ensure parents and carers are supported with school related purchases when necessary	<p>In the 2022 to 2023 year:</p> <p>Target: Funding will be provided by the school to support school uniform purchasing, educational visits and Breakfast Club when needed by parents in receipt of Pupil Premium.</p> <p>Review: Pupil Premium has been used support families accessing Breakfast Club and with transport. Educational Visits are covered above. Parents and carers have all had access to pre-loved uniform stocks (where all uniform is sold for £1).</p>
